"Obligated Entity" means the distribution licensees, consumers owning captive power plants (Any person who owns a grid-connected Captive Generating Plant based on conventional fossil fuel with installed capacity of 1 MW and above, or such other capacity as may be stipulated by the State Commission from time to time, and consumes electricity generated from such Plant for his own use shall be subject to RPO to the extent of a percentage of his consumption met through such fossil fuel-based captive source;), and open access consumers (Any person

having a Contract Demand of not less than 1 MVA and who consumes electricity procured from conventional fossil fuel based generation through Open Access shall be subject to RPO to the extent of a percentage of his consumption met through such fossil fuel-based Open Access source:) in the State of Maharashtra. Captive user(s) consuming power from grid connected fossil fuel based cogeneration plants are not exempted from applicability of RPO. Every Obligated Entity may meet its RPO target by way of (i) Own generation or procurement of power from RE developer or (ii) Purchase from other licensee or (iii) Purchase of renewable energy certificate or (iv) Combination of any of the above options Obligation to purchase electricity generation based on solar as RE source can be fulfilled by purchase of solar certificates only.

ZP Ratnagiri intends to sale of the energy produced to the highest bidder from its Solar Power Plant having capacity of 1 MW installed at Village Golap under following conditions:

- 1. Assured generation of 1850 MWH metered in Pawas II OBLIGATORY substation
- 2. Minimum base tariff of Rs 4.00 per kwh
- 3. Lock in period of 6 years
- 4. Escalation of rate every 3 years by 5%

Payment Terms:

Obligatory shall make payment of the amounts due in Indian Rupees within thirty (30) days from the date of receipt of the Tariff Invoice raised by the designated office of the ZP Ratnagiri.

Payment Security:

Letter of Credit:

a) OBLIGATORY shall establish and maintain irrevocable and unconditional revolving Letter of Credit in favour of, and for the sole benefit of, ZP Ratnagiri - Solar Power Producer for the contacted capacity. All the cost incurred for

opening, maintenance and other cost related to establishment of Letter of Credit shall be borne by the OBLIGATORY.

- b) The Letter of Credit shall be established in favour of, and issued to, ZP Ratnagir the Solar Power Producer on the date hereof and made operational thirty (30) days prior to due date of first invoice and shall be maintained consistent herewith by OBLIGATORY and all times during the Term of the Agreement.
- c) Such Letter of Credit shall be in form and substance acceptable to both the Parties and shall be issued by any Nationalized or Scheduled Bank and be provided on the basis that:
- i. In the event a Tariff Invoice or any other amount due and undisputed amount payable by OBLIGATORY pursuant to the terms of this Agreement is not paid in full by OBLIGATORY as and when due, the Letter of Credit may be called by the ZP Ratnagiri Solar Power Producer for payment of undisputed amount.
- ii. The amount of the Letter of Credit shall be equal to three months projected payments during first contract year and thereafter during each contract year, the amount of Letter of Credit shall be equal to one month"s average billing of previous contract year.

Obligated Entity should provide following documents along with their offer:

- 2. GST Certificate
- 3. Audited Annual Balance sheets for 3 years
- 4. CA Certified Turnover Certificate
- Electrical bill snowing clearly connected load, location and consumer number.
